Purpose. The 5-Year and Annual PHA Plans provide a ready source for interested parties to locate basic PHA policies, rules, and requirements concerning the PHA's operations, programs, and services, and informs HUD, families served by the PHA, and members of the public of the PHA's mission, goals and objectives for serving the needs of low- income, very low- income, and extremely low- income families.

Applicability. Form HUD-50075-ST is to be completed annually by **STANDARD PHAs or TROUBLED PHAs**. PHAs that meet the definition of a High Performer PHA, Small PHA, HCV-Only PHA or Qualified PHA do not need to submit this form.

Definitions.

- (1) **High-Performer PHA** – A PHA that owns or manages more than 550 combined public housing units and housing choice vouchers, and was designated as a high performer on both of the most recent Public Housing Assessment System (PHAS) and Section Eight Management Assessment Program (SEMAP) assessments if administering both programs, or PHAS if only administering public housing.
- (2) **Small PHA** - A PHA that is not designated as PHAS or SEMAP troubled, or at risk of being designated as troubled, that owns or manages less than 250 public housing units and any number of vouchers where the total combined units exceeds 550.
- (3) **Housing Choice Voucher (HCV) Only PHA** - A PHA that administers more than 550 HCVs, was not designated as troubled in its most recent SEMAP assessment and does not own or manage public housing.
- (4) **Standard PHA** - A PHA that owns or manages 250 or more public housing units and any number of vouchers where the total combined units exceeds 550, and that was designated as a standard performer in the most recent PHAS or SEMAP assessments.
- (5) **Troubled PHA** - A PHA that achieves an overall PHAS or SEMAP score of less than 60 percent.
- (6) **Qualified PHA** - A PHA with 550 or fewer public housing dwelling units and/or housing choice vouchers combined, and is not PHAS or SEMAP troubled.

The PHA may incorporate information on occupancy by over-income families into its PHA Plan statement of deconcentration and other policies that govern eligibility, selection, and admissions. Occupancy by Police Officers. The PHA may allow police officers who would not otherwise be eligible for occupancy in public housing, to reside in a public housing dwelling unit. 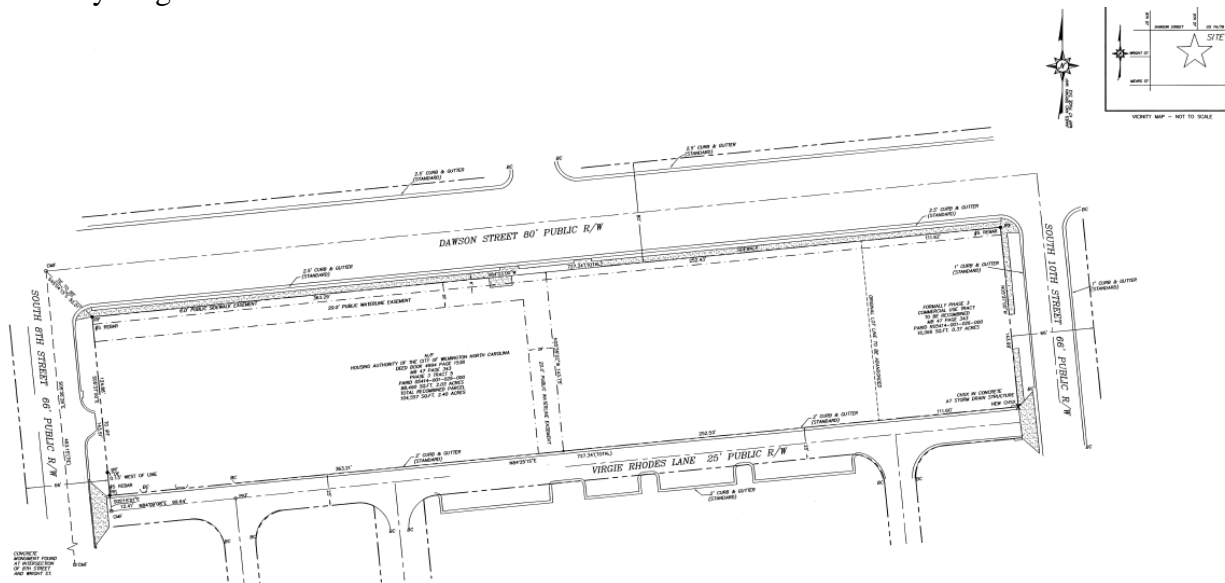
Housing Authority of the City of Wilmington, North Carolina Amendment to the 2017 Annual Plan

A. Introduction

The Housing Authority of the City of Wilmington, North Carolina (Authority) is amending its Annual PHA Plan in accordance with 24 CFR 903.21 because it is exploring options to construct new public housing units on property it owns on Dawson Street in the City of Wilmington. Development Plans are considered a Significant Amendment to the Authority's Annual and/or Five Year Plan.

B. Development Information

Development plans are in the initial conception phase and are subject to change throughout the predevelopment process. The Authority owns a 2.4 acre parcel of land on Dawson Street between South Eighth Street and South Tenth Street, New Hanover County Parcel ID 05414-001-025-000 and identified as Phase 3 Tract 5 of the Robert S. Jervay neighborhood.



The proposed site of development is currently unimproved land with the exception of a 6,500 SF building known as Pearce House on the western portion of the property (corner of S. 8th St. and Dawson). While the plan is currently in the predevelopment stage and subject to change, WHA is exploring the option of developing the parcel in up to two phases. WHA is proposing to construct three (+/-) new multi-story apartment buildings containing a mixture of one and two bedrooms on the parcel. One building would be located to the east of the current Pearce House supportive housing apartment at 809 Virgie Rhodes Lane. A Wilmington Heritage Tree Award winning Live Oak tree in the middle of the property would separate the buildings, with the second and third buildings being constructed to the east of the tree. Construction is slated to begin late 2017 or early 2018.
